



**RELEASE OF LORRIE HILLIER KRUSE A/K/A LORRIE KRUSE

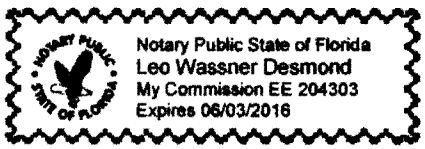
