ADJUDICATION: Adjudicate Withhold Court's Discretion

If the Defendant is convicted of possession, sale, trafficking, or conspiracy to possess, sell, or traffic in any controlled substance, the Court directs the Department of Highway Safety and Motor Vehicles to revoke the Defendant's driver's license for two (2) years. If the Defendant is convicted of theft of a motor vehicle; theft of motor vehicle parts; or any felony in the commission of which a motor vehicle was used, the Court directs the Department of Highway Safety and Motor Vehicles to revoke the Defendant's driver's license as mandated by law. The Clerk is directed to make the proper notifications.

SENTENCE: Standard Fines and costs are applied to all qualifying counts.


